Aboriginal and Torres Strait Islander Health Award Nomination Form

ANZCA is committed to addressing Indigenous health inequities in Australia and Aotearoa New Zealand. The Aboriginal and Torres Strait Islander health award recognises an ANZCA fellow, trainee, Specialist International Medical Graduate (SIMG) or a group of members (maximum 5) who have made a significant and sustainable contribution to Aboriginal and Torres Strait Islander health through a public health initiative or research project.

Eligibility criteria

- Award nominee must be an ANZCA member (fellow, trainee or SIMG).
- Up to five ANZCA members may be nominated for a group award.
- The initiative or project must have commenced within the past two years.

Nomination information

Nominations can be made by the nominee, an ANZCA fellow or trainee, ANZCA regional committee, or an Indigenous organisation or community.

Nominations are to be made to the Indigenous Health Committee (Indigenoushealth@anzca.edu.au) through the completion of this nomination form.

Selection

A panel of three assessors convened by the Indigenous Health Committee will assess the nominations against the selection criteria and recommend a winner to the Professional Affairs Executive Committee.

Alignment - 10 points
